The Lagos State Government through the Federal Republic of Nigeria has received financing from Agence Française de Développement ("**AFD**") for the Lagos Strategic Transport Master Plan Project (LSTMPP) 1 and intends to use part of the funds thereof for payments under the following services:

## Consultancy Service for the Detailed Engineering Design and Supervision of Construction of Quality Bus Corridor Package 1, 2 and 3

The Services of the consultant shall consist of detailed engineering designs of the eight quality bus corridors grouped as packages 1, 2 & 3, preparation of bidding documents, and supervision of construction of infrastructure for the quality bus corridors. The services are anticipated to be carried out simultaneosly.

#### Phase 1 – Detailed Engineering Design

To undertake the detailed design for all building, mechanical, electrical, structural, highway and traffic and civil facilities needed to provide a functional infrastructure that would support operations of high capacity passengers buses along Quality Bus Corridor Package 1 (Ketu-Alapere, Anthony–Oshodi, Onipanu-Oshodi, Ojuelegba-Idi Araba, Yaba-Lawanson-Cele), Package 2 (Iju Ishaga - Abule Egba, Iyana Ipaja - Ayobo) and Package 3 (Iyana Iba-Igando), and supported by necessary ground surveys (topographical, hydrology, geotechnical etc) work as required. These civil facilities include but not limited to the scope of services below:

#### **Scope of Services**

- Carry out such field investigations and studies of road inventory, structures, traffic, soils, construction materials, drainage and construction prices as are required to adequately dimension and cost the design options;
- Prepare detailed engineering road design for corridors requiring full reconstruction;
- Prepare localized repair options in terms of cross sectional, horizontal and vertical alignment, drainage and pavement design (to include for relevant materials experimentation) for corridors requiring rehabilitation;
- Prepare detailed junction design for corridors requiring rehabilitation;
- Assess the environmental impact and propose in sufficient detail mitigation measures to counter any negative impact;
- Prepare detailed terminal designs for corridors requiring construction of terminals; this includes structural, mechanical and electrical design drawings and calculations.

- Determine the extent of erosion damage and propose appropriate mitigation measures that include all necessary protection against the various recurrence floods and based on the detailed hydrological risk analysis done elsewhere.
- Locate suitable material, in sufficient quantities to rehabilitate the erosion and undertake all necessary material testing and draft any related special conditions and technical specifications
- Prepare the bills of quantities, technical specifications (based on FMW 1997 standards), an Engineer's confidential detailed cost estimate and the proposed construction price schedule

#### Phase 2- Assistance to LAMATA during the bidding process

The consultant shall be available to provide technical support as required by LAMATA during bidding process.

#### Phase 3 - Supervision of Construction works.

To supervise the construction and installation of all facilities and civil works for the Quality Bus Corridor **package 1** (Ketu-Alapere, Anthony–Oshodi, Onipanu-Oshodi, Ojuelegba-ldi Araba, Yaba-Lawanson-Cele), **Package 2** (Iju Ishaga - Abule Egba, Iyana Ipaja - Ayobo) and **Package 3** (Iyana Iba- Igando) to the satisfaction of the client, and which arise from the detailed design activities undertaken. To ensure that high quality construction with detailed supervision is achieved and to ensure that all associated works are carried out in full compliance with the engineering design, working drawings, bill of quantities, technical specification and other contract documents. The supervision of the construction of the three packages is expected to be done concurrently and scope of works is as enumerated below

#### **Scope of Services**

- give the order to commence the works and variation orders to the Contractors;
- approve the materials, equipment and procedures for casting and installation of piles;
- approve quality of the works in accordance with the contract specifications;
- approve the contractor's work program, method statement and the source of materials;
- issue monthly progress reports;
- approve and/or issue working drawings, approve the setting out of the works and give instructions to the contractor;
- make measurements and keep the measurement books;
- issue interim certificates for monthly payments to the contractors, certify completion of parts or totality of works;
- order tests of materials, order removal of improper works; advise LAMATA on all matters relating to the execution of the contract, including the processing of contractor's claims
- ensure compliance to Environmental, health and safety guidelines

The Lagos Metropolitan Area Transport authority (LAMATA) hereby invites eligible consultants to show their interest in delivering the Services described above.

This Request for Expressions of Interest is open to: Consulting Firms

Eligibility criteria to AFD financing are specified in sub-clause 1.3 of the "Procurement Guidelines for AFD-Financed Contracts in Foreign Countries", available online on AFD's website: http://www.afd.fr.

If the consultant is a Joint Venture (JV), the Expression of Interest shall include a copy of the JV Agreement entered into by all members. Alternatively, a letter of intent to execute a JV Agreement in the event of a successful proposal shall be signed by all members and submitted with the Expression of Interest, together with a copy of the proposed Agreement.

The construction supervision of the three QBCs is planned to be run concurrently, interested consultants must provide information evidencing that they are qualified and experienced to perform those Services. For that purpose, documented evidence of recent and similar services shall be submitted.

The services are anticipated to start by May, 2020 over a period of 6 months for design and 12 months for construction supervision of the QBCs after engagement of contractor(s).

Determination of the similarity of the experiences will be based on:

- The contracts size;
- The nature of the Services: detailed engineering designs and construction supervision arising from design activities undertaken.;
- The technical area and expertise: expertise in road design & construction, structural
  design of transport infrastructure, bridge, etc and construction supervision of road and
  transport infrastructures, bridge structures, urban bus system planning and operations,
  Environmental and Social safeguard and other engineering fields related to the above
  scope of work.
- The location: Lagos, Nigeria or cities with similar socio-economic charateristics.

LAMATA will also take into account during the evaluation of the applications the following items:

- Availability of technically skilled and sufficient personnel
- Relevant experience in projects of similar nature and complexity
- Evidence of Similar experience in sub saharan African region
- The services shall be provided by combination of international and National firms in adequate and appropriate ratio.
- Availability of Quality Management Systems Certification (ISO 9001:2015/45001) or equivalent;
- Evidence of Membership with Related Professional Bodies;

#### In case of JV or Consortium:

- General introduction about the leading firm and its potential partners;
- Justification of consortium or JV in those both cases: complementary capacities and key technical fields of the consortium;
- List of relevant experiences and brief description of similar projects/assignments addressing requirements described above in terms of the scope of work;
- For each member of the consortium: registration details of the firms, Availability of Quality Management Systems Certification(s) or equivalent;

Among the submitted applications, LAMATA will shortlist a maximum of six (6) Applicants. An AFD's standard form of Statement of Integrity, Eligibility and Social and Environmental Responsibility, duly signed by the Firm/JV, must be provided with the application. ### Statement of Integrity, Eligibility and Environmental and Social Responsibility

- 1. As a matter of consequence, no legal relationship exists between AFD and our company, our joint venture or our suppliers, contractors, subcontractors, consultants or subconsultants. The Contracting Authority retains exclusive responsibility for the preparation and implementation of the procurement process and performance of the contract. The Contracting Authority means the Purchaser, the Employer, the Client, as the case may be, for the procurement of goods, works, plants, consulting services or non-consulting services.

- 3. We hereby certify that neither we, nor any of the members of our joint venture or any of our suppliers, contractors, subcontractors, consultants or subconsultants are in any of the following situations of conflict of interest:
  - 3.1 Being an affiliate controlled by the Contracting Authority or a shareholder controlling the Contracting Authority, unless the stemming conflict of interest has been brought to the attention of AFD and resolved to its satisfaction;
  - 3.2 Having a business or family relationship with a Contracting Authority's staff involved in the procurement process or the supervision of the resulting Contract, unless the stemming conflict of interest has been brought to the attention of AFD and resolved to its satisfaction;
  - 3.3 Being controlled by or controlling another bidder or consultant, or being under common control with another bidder or consultant, or receiving from or granting subsidies directly or indirectly to another bidder or consultant, having the same legal representative as another bidder or consultant, maintaining direct or indirect contacts with another bidder or consultant which allows us to have or give access to information contained in the respective applications, bids or proposals, influencing them or influencing decisions of the Contracting Authority;
  - 3.4 Being engaged in a consulting services activity, which, by its nature, may be in conflict with the assignments that we would carry out for the Contracting Authority;
  - 3.5 In the case of procurement of goods, works or plants:
    - Having prepared or having been associated with a consultant who prepared specifications, drawings, calculations and other documentation to be used in the procurement process of this Contract;
    - b) Having been recruited (or being proposed to be recruited) ourselves or any of our affiliates, to carry out works supervision or inspection for this Contract.
- 4. If we are a state-owned entity, and to compete in a procurement process, we certify that we have legal and financial autonomy and that we operate under commercial laws and regulations.
- 5. We undertake to bring to the attention of the Contracting Authority, which will inform AFD, any change in situation with regard to points 2 to 4 here above.
- 6. In the context of the procurement process and performance of the corresponding contract:
  - 6.1 We have not and we will not engage in any dishonest conduct (act or omission) deliberately indented to deceive others, to intentionally conceal items, to violate or vitiate someone's consent, to make them circumvent legal or regulatory requirements and/or to violate their internal rules in order to obtain illegitimate profit;
  - 6.2 We have not and we will not engage in any dishonest conduct (act or omission) contrary to our legal or regulatory obligations or our internal rules in order to obtain illegitimate profit;
  - 6.3 We have not promised, offered or given and we will not promise, offer or give, directly or indirectly to (i) any Person who holds a legislative, executive, administrative or judicial mandate within the State of the Contracting Authority regardless of whether that Person was nominated or elected, regardless of the permanent or temporary, paid or unpaid nature of the position and regardless of the hierarchical level the Person occupies, (ii) any other Person who performs a public function, including for a State institution or a State-owned company, or who provides a public service, or (iii) any other person defined as a Public Officer by the national laws of the Contracting Authority's country, an undue advantage of any kind, for himself or for another Person or entity, for such Public Officer to act or refrain from acting in his official capacity;
  - 6.4 We have not promised, offered or given and we will not promise, offer or give, directly or indirectly to any Person who occupies an executive position in a private sector entity or works for such an entity, regardless of the nature of his/her capacity, any undue advantage of any kind, for himself or another Person or entity for such Person to perform or refrain from performing any act in breach of its legal, contractual or professional obligations:
  - 6.5 We have not and we will not engage in any practice likely to influence the contract award process to the detriment of the Contracting Authority and, in particular, in any anti-competitive practice having for object or for effect to prevent, restrict or distort competition, namely by limiting access to the market or the free exercise of competition by other undertakings;

- 6.6 Neither we nor any of the members of our joint venture or any of our suppliers, contractors, subcontractors, consultants or subconsultants shall acquire or supply any equipment nor operate in any sectors under an embargo of the United Nations, the European Union or France;
